1. I understand that a 10% Buyer's Premium must be paid by the high bidder to the Special Master on or before February 18, 2026. The Buyer's Premium is non-refundable and will not be refunded to me under any circumstances.
2. I understand that in order to register to bid in the online auction I must remit a **\$10,000.00 bid deposit** via wire transfer, irrevocable ACH transfer via Earnnest, or cashier's check **made payable to Tranzon Driggers Escrow Account**.
